It is therefore possible in individual cases to obtain **exceptional permission** from the **relevant customs authorities**. The list is regularly updated by the German Association of the Automotive Industry (Verband der Automobilindustrie, VDA) in the Export-Homologation work group.

The following must be informed of a correction of the vehicle identification number (VIN) on vehicles for a destination country other than those listed in the above table:

Certification & Support Electric (EVTAC), the responsible customer centre (SNV) and the responsible shipping office in every case, and also

- for **CBU deliveries**, the Commercial Order Processing department at the Order Center (**SNC**), and
- for **CKD deliveries**, the Commercial Order Processing department at the Order Center (**SNC**) and
- the central office for the vehicle information system in Corporate After Sales (**FISS**)
